In 2016, MADRE expanded our work under our three major initiatives: (1) Ending Rape as a Weapon of War, to prevent wartime rape and protect survivors, (2) Women Climate Defenders, to sustain women's vital interventions against climate change, and (3) LGBTIQ Rights, to join together with our partners against attacks on our gender and sexuality.

We also began to lay the groundwork for our fourth initiative, Fighting for Feminist Futures. This effort confronts right-wing populism and authoritarianism and supports feminist organizing in defense of communities in the US and abroad that are threatened by destructive US policies. Each of these initiatives reflects our dual approach of strengthening grassroots women's organizations while advocating for human rights.

We also continued to operate our emergency and humanitarian relief programs, through which we mobilized urgent responses to catastrophe and delivered over \$1.4 million worth of humanitarian aid to the communities of our grassroots sister organizations.

Highlights of accomplishments in these areas are below.

(1) Ending Rape as a Weapon of War

Through this initiative, MADRE confronts the use of rape as a weapon of war by setting up community-based services for care, counseling and shelter, and by demanding policy change to protect women and prevent rape. Key examples are below:

- In Colombia, MADRE brought urgent care, healing art therapy and trauma counseling to former girl child soldiers and survivors of wartime sexual violence to help them rebuild their lives.
- In Iraq, we sheltered women and girls fleeing ISIS sexual slavery, providing urgent safety, medical care, counseling, vocational trainings and healing.
- MADRE also leads an international advocacy effort to challenge the Iraqi government's ban on NGO-run women's shelters, places where rape survivors find healing and hope. With our grassroots partners, we have already won victories when local officials allowed NGO's to run safe houses in their jurisdictions. Now, we are using those precedents to push for a change in national policy.

**(2) Women Climate Defenders**

Through this initiative, we amplify the voices of women on the frontlines of our global climate crisis. MADRE's grassroots partners confront poverty and discrimination that leave them especially vulnerable to climate threats like droughts and food shortages. With MADRE support, these women have innovated concrete strategies to protect local communities. Together, we advocate for policymakers to replicate and sustain grassroots women's solutions. Key examples are below:

- In Kenya, frequent droughts devastate rural communities, leaving their land parched and threatening lives. In 2016, MADRE and our local partners trained Indigenous women farmers to harvest rainwater and to store food through drought. We also produced and distributed energy-saving cook-stoves to 100 Indigenous women-headed households, coupled with trainings on clean energy. We supported reforestation efforts, enabling Indigenous women to plant 400 trees and establish

tree nurseries within their communities. And we coordinated sessions with Forest Department officials to inform community members about the importance of reforestation.

- In Nicaragua, we work with our local partner to train and provide seeds to women for organic farming and to create new opportunities for women to sell their produce locally at farmers markets. The farmers markets offer a vital source of income for these women and their families. With the money the women farmers earn from selling their produce, they can buy necessities for their children, like shoes, clothes and schoolbooks.

- We brought a delegation of Indigenous women to the United Nations, a key international advocacy space, to share their demands and solutions. By providing training and support for their participation, we created an elevated policy platform for Indigenous women's sustainable climate solutions.

With our support, our partners build local expertise in confronting climate change, and together, we push for sustainable climate policies that are rooted in their solutions, including at the international level.

**(3) LGBTIQ Rights**

Through our LGBTIQ Rights initiative, we support the grassroots organizing of local women and LGBTIQ activists, creating safe spaces in dangerous places to share strategies, create campaigns and build power together. We advance these demands in the international arena, upholding the right to exercise and express sexuality and gender identity, and to be protected from violence and discrimination. Key examples are below:

•In 2016, MADRE and our Iraqi partners expanded our Room for All, a safe space for people to come together in dialogue to discuss harmful stereotypes against LGBTIQ Iraqis and promote acceptance. These gatherings are joyful occasions, featuring theater, poetry and music, attracting even more people to join this growing community of rights supporters.

•Together with our Iraqi partners, we also unite the struggles of women and LGBTIQ people by ending impunity for crimes against them, reducing harmful stigma and promoting positive social norms. MADRE and our allies are now petitioning the International Criminal Court to investigate crimes against gender non-conforming individuals in Iraq by ISIS and other perpetrators.

**(4) Humanitarian Aid and Emergency Relief**

Through our humanitarian aid program, called Helping Hands, MADRE provides women and families in the communities of our sister organizations with vital supplies like medicines and medical equipment, classroom materials, prenatal vitamins, maternity supplies and more. In 2016, we sent shipments valued at over \$1.4 million.

In 2016, we also responded to emergencies in Syria, Haiti, and Nicaragua. In December 2016, when Syrian government forces laid siege in Aleppo, reports from the ground indicated that people, including women and children, were shot in the streets and in their homes. MADRE was able to respond with lifesaving aid and care. We joined a convoy of trucks that brought incubators, infant ventilators, hospital beds and other medical aid and supplies to rebuild and stock a children's hospital in Aleppo.

In Haiti, in response to the October 2016 hurricane, MADRE supported our local partner in their distribution of humanitarian aid kits to the Haitian LGBTIQ community, after reports of people being refused assistance on the basis of their sexual orientation. We also provided medical care, psychosocial support and access to safe housing to 500 members of the Haitian LGBTIQ community.

And in Nicaragua, we supported the emergency relocation of some of those most at-risk due to the ongoing land grabs, and resulting violence, that has been occurring in the Indigenous communities along the North Atlantic Coast of Nicaragua where MADRE has been working with our local partner since 1983.
